What you need to know about registering your motor vehicles with test drive and transfer license plates to the GO toll system

Please note: You need to send us evidence of the rate-relevant characteristics of motor vehicles with test drive and transfer license plates, always subsequently and for the period in question. As period applies the time from the 1st to the 15th or from the 16th to the last of a calendar month.

Send us the evidence

- for the period from the 1st to the 15th to the end of the month and
- for the period from the 16th to the end of the month to the 15th of the following month.

The verification documents must clearly show

- with which vehicle you drove on the Austrian toll road network at what time.
- which rate-relevant characteristics are to be assigned to the corresponding vehicle.

Rate characteristics requiring evidence:

- CO₂ emission class **5**, **4**, **3**, **2**
- EURO emission class EURO VI, EEV, EURO V, EURO IV
- Vehicle typ **bus**

No evidence required:

- CO₂ emission class 1
- EURO emission class EURO III, EURO II, EURO I
- Regardless of the emission class, the **vehicle type bus** is always subject to verification.

Which documents are required to prove the rate-relevant characteristics?

- Vehicle registration certificate of the motor vehicle (all pages)
- Customer Information File (CIF)
- Certificate of Conformity (CoC)
- CEMT-Nachweis der Übereinstimmung mit den technischen und Sicherheitsanforderungen für ein Kraftfahrzeug
- Conformity of Production (CoP)

How can you send us the documents?

• Upload to the SelfCare Portal at go-maut.at

Please send us the verification documents in PDF, JPG or TIF format. Other formats are not processed by us and the evidence is considered as not having been provided!

In the case of test drive or transfer license plates, make sure that all information about your vehicle is correct and that it corresponds to the information stored on the very GO-Box that is attached to the vehicle when using the toll road network.
